Coaches:

The AA District 3 Sectional II Tournament for your team will be hosted by Central Dauphin East High School. The tournament will be held on **Saturday, February 17, 2024.** Skin-checks begin at 8:45 AM, weigh-ins at 9:00 AM and wrestling begins at 10:00 AM.

The seeding meeting scheduled for <u>Wednesday</u>, <u>February 14</u>, <u>2024</u>, <u>at 6:30 PM</u> at Central Dauphin East High School in Tech Room III. *Food and beverages provided*. The entrance for the meeting is through the main gymnasium area off Union Deposit Road.

All entries must be submitted electronically.

All wrestlers will be seeded and positioned during the seeding meeting. To be considered for a first or second seed, a wrestler must have at least 10 bouts, for a third or fourth seed, 8 bouts, and for a fifth or sixth seed, 6 bouts. (The required numbers of bouts are not needed if an injury prevented competition.) We will seed only the top 8 with an alternate available.

Coaches may question his wrestler's seed if he feels he has not received proper consideration. According to the guidelines, you have thirty seconds to explain your case. After that time, the remaining coaches will vote to accept or reject your plea.

You must print out the NWCA form on each of your wrestlers for the meeting. You will also need to enter your wrestlers at the following web site: www.boutmastersLLC.com by Wednesday, February 14, 2024, <a href="https://www.boutmas

It is necessary that you bring two copies of the <u>NWCA weigh in Roster (including all eligible wrestlers)</u>, and <u>NWCA Summary Sheet of each wrestler's opponents</u> to our February 14th meeting. If you have any NWCA questions, contact Pat Tocci at <u>ptocci@nwca.cc.</u> You do not need to bring the PIAA Eligibility Sheet this year. Info is now on-line if needed.

Remember, your wrestler is locked into the weight class he is entered at the seeding meeting. Once the seeding sheet is submitted, you may not change a wrestler's weight class without the approval directly from the District 3 Wrestling Chairman (Greg Goldthorp and Mike Craig).

Notification of substitution should be made as soon as possible but will not be accepted after the first weigh in for the tournament has taken place. When subbing in the sectional round, the next lower seed will move up and the sub will wrestle in the last bracket vacated by the movement of the seeds.

For subsequent rounds, if you have an advancing wrestler who is injured or questionable, please inform Greg Goldthorp as soon as possible so the substitute can be contacted. There will be no substitution after the weigh-in are closed.

All championship rounds are 2-2-2 and all wrestle-backs will be 1-2-2.

Your materials and brackets for a qualifying wrestler(s) for the district/regional round must be picked-up at the end of sectionals.
